1. TERMS AND DEFINITIONS USED IN THE AGREEMENT

User Agreement is a contract concluded between the Parties by the User Accepting the Offer proposed by Myriad Studio, and regulating the relations of the Parties arising from the User's use of the Services provided by the Product.

Offer is Myriad Studio's offer addressed to a potential User to conclude an User Agreement with them (the User is considered to have entered into such a User Agreement upon Accepting the Offer that contains all the material provisions of the User Agreement and sets forth all the rights, obligations, responsibilities and interaction procedures of the Parties, including the procedure for concluding and terminating this Agreement or some of its parts between the Parties.

Acceptance is the User fully and unconditionally accepts the Offer and, accordingly, the terms of the User Agreement as amended at the time of the actual use of the Services, as well as concludes the User Agreement by joining it, by performing actions aimed at using the Product and/or Services in any manner, including but not limited to: visiting and using the Web Portal, following the links from the Web Portal to other resources, downloading, installing and using Applications, sending messages through feedback forms, accessing the Crypto section and/or the functionality of the Product's Smart Contracts, including by making Transactions, as well as using a Crypto Account as a digital signature for concluding and certifying transactions, contracts and/or agreements by means of Transactions, as well as acquiring, exchanging and/or using Crypto Assets on the terms established by the present Agreement or other transactions, and/or in a manner implemented by the logic of Smart Contracts, as well as any other actions related to using the functionality of the Services.

Continued use of the Services after a new version of the User Agreement comes into force shall imply that the User agrees with it, and that the provisions of this new version shall apply to the User in full.

Parties are Myriad Studio and the User.

Myriad Studio refers to the company named MYRIADGAMESSTUDIO LLC (KIOJI: 55632701, INN: 02328748, Armenia), which holds all the necessary rights to the Product to conclude a User Agreement and/or a license agreement and/or other agreements/contracts made in the form of an offer or other legal means with the User.

User is an individual who: acts as a private person on their own behalf, or with the consent and upon notification of a legal representative, or on behalf of another person as a legal representative, or as a business owner, or as a representative of a legal entity; has reached the appropriate age according to the laws of the country of citizenship/affiliation/residence; has the appropriate right to enter into this User Agreement; uses the Services and is exempt from any legal restrictions on the use of the Product and/or Services for the purposes intended by such services.

Affiliates are official representative offices, parent companies, subsidiaries, branch offices, divisions or other legal entities that are part of a group of companies and associated with Myriad Studio on the basis of mutual participation and/or contract.

Copyright Holders are individuals/legal entities that hold **Exclusive Rights** in relation to the **Product, Content**, and any results of intellectual activity related to the Product, including the right to use and/or dispose of them.

Administration is a person or group representing Myriad Studio who are responsible for controlling the operation of the Services and the Social Media of the Product, as well as monitoring the Users' compliance with the terms of the User Agreement and any other applicable regulations and requirements.

Smart Contract Initiator (hereinafter referred to as the Initiator) is a subject (individual), and/or organization (legal entity), and/or logical structure implemented in software code (which initiates the Smart Contract), and/or the Public address of the Crypto account (on behalf of which a Smart Contract is created and/or initiated (launched) in the Blockchain network and/or Transactions are carried out in the Smart Contracts themselves) which acts as the customer and/or source of development, creation and/or launch of the Smart Contract code in the Blockchain network. The Initiator determines the parameters of the Contract, its structure, logic and rules of operation, including, but not limited to: the rights and restrictions of the Smart Contract participants (the Crypto Accounts), the scope of rights for Smart Contract access and management, as well as the procedure and conditions for changing the parameters of the Smart Contract or updating it; can also fulfill the role of the Smart Contract Owner.

Smart Contract Owner is a subject (individual) and/or organization (legal entity) and/or logical structure implemented in software code (Smart Contract) and/or Public Address of the Crypto Account (on behalf of which Transactions and/or

management of the Smart Contract are carried out) which has control over, and the right to own or co-own, a Smart Contract within the framework of its inherent logic and functions, including, but not limited to: amending, changing parameters, carrying out Transactions, managing balances, activating and deactivating functions, as well as determining parameters, access rights, and the scope of rights and obligations of Smart Contract Participants (Crypto Accounts), assigning and delegating and/or transferring rights to manage the Smart Contract to a Smart Contract Operator, and disposing of Crypto Assets within the Smart Contract to the extent of their rights; can fulfill the role of the Smart Contract Operator.

Smart Contract Operator is a subject (individual) and/or organization (legal entity) and/or logical structure implemented in software code (Smart Contract) and/or Public Address of the Crypto account (on behalf of which Transactions and/or management of the Smart Contract are carried out) which monitors and manages all or individual functions of the Smart Contract to the extent of the rights and restrictions granted to them, as well as the embedded logic with the Smart Contract, including, but not limited to: verifying and authorizing Transactions, executing the logic of the Smart Contract, managing access rights, registering events, and collecting/processing information.

Smart Contract Participant is a User and/or logical structure implemented in software code (Smart Contract) and/or the Public Address of the Crypto Account (on behalf of which Transactions and/or participation in Smart Contracts are carried out) which takes part in and/or enters into a contractual relationship with the Smart Contract as a subject/party, with rights and obligations as stipulated by the terms and program logic contained in said Smart Contract.

Acquirer is a User and/or logical structure implemented in software code (Smart Contract) and/or the Public Address of the Crypto Account (on behalf of which Transactions and/or participation in Smart Contracts are carried out) who have reached the legal age according to the applicable legislation of their country of citizenship / affiliation / residence, possess the appropriate rights and are exempt from any legislative or regulatory restrictions in their country of citizenship / affiliation / residence / registration / activity, and who have reached the appropriate age according to the applicable legislation of their country of citizenship / affiliation / residence to acquire, own and subsequently use Crypto Assets or Project Tokens for the purposes provided by the Service and/or in other ways.

AML is Anti Money Laundering, a set of measures and policies developed with the goal of preventing the abuse of the financial system for legalizing proceeds from criminal activity.

KYC is the process of verifying the identity of the User, Smart Contract Participant, Acquirer or other identities prior to their registration and/or other activities in the Services and/or Smart Contracts.

Beneficial Owner is an individual who takes any advantage of or control over another person or in respect of a company is the individual who legally owns or controls the company directly or indirectly by whatever means.

Governmental Authority means any nation or government, any state or other political subdivision thereof, any entity exercising legislative, judicial, or administrative functions of or pertaining to government, including, without limitation, any government authority, agency, department, board, commission or instrumentality, and any court, tribunal or arbitrator(s) of competent jurisdiction, and any self-regulatory organization.

Laws means laws, statutes, ordinances, rules, regulations, judgments, injunctions, orders and decrees of the Acquirer's country of origin.

Whitepaper refers to the document which describes the Product, the Crypto Assets, the Services and other aspects related to the Product, and is available on the following Website: <https://action.myriadgames.studio/whitepaper>. Myriad Studio has the right to make edits, changes and amendments, as well as add new provisions to the Whitepaper from time to time at its sole discretion, which all parties using the Product and/or its derivatives in any direct and/or indirect way shall be obliged to keep themselves up to date with.

Gaming software product "Action" (hereinafter "the Product") is understood in the present Agreement as a complex Software suite composed of interacting programs, websites and third-party services coordinated in functions and formats and representing a complete toolset for implementing Gameplay Process in the Video Game in order to provide services to users with the help of Services.

The Product can be altered and improved in the process of its creation or afterwards, wherein all rights and obligations with respect to the parties holding exclusive rights are preserved.

"Action" - refers to the project name of the Product and is subject to change upon Agreement between parties holding exclusive rights for the Product.

Services of the gaming software product (hereinafter “the Services”) are functionalities available to Users using the Product, which are provided on a reimbursable or non-reimbursable basis based on the deals/obligations/regulations concluded with Users, including:

Information resources are informational and technical capabilities of the Product that allow Users to receive and interact with Content by means of its visualization/demonstration/reproduction.

Entertainment services are rendered by implementing the Game Process and enable Users to obtain results as provided by said process in the form of receiving Game Content by means of its visualization/demonstration/reproduction.

Paid services are additional features (extended) or specialized capabilities of Information Services and/or Entertainment Services provided on a paid basis and/or other basis as stipulated by Myriad Studio by means of providing access/rights/licenses or directly providing services by Myriad Studio and subject to payment or other means of reimbursement by the User with the help of a Payment Service or Crypto Service, or in any other manner agreed upon by the Parties.

Payment Service is a service provided by a bank (a loan institution or an organization that has entered into an appropriate agreement with a loan institution) and/or another organization (agent) in possession of the necessary licenses/rights to carry out transactions using an online service and the Internet, including: receipt/processing and/or non-cash transfer of the User’s funds as payment for providing access to paid or restricted resources of the Service.

The Crypto Service is a service that enables users to use Crypto Assets of the Project for the purposes provided for by the Game Process, and/or to gain access to Paid Services, and/or for other purposes provided for by the Smart Contracts.

Service Tools enable Users to carry out Registration, Authorization, Authentication and gain access to Services and/or pay for applicable services, etc.

Support Services are services that enable Users to receive informational assistance or contact technical support.

Software complex represents a set of programs, data, commands, and instructions, including source code and object code (software logic), created based on programming languages, as well as third-party plugins and assets, intended for the software functioning of a Video Game, Server-side, Web Portal, Database, Crypto-section, and their interaction with each other.

Video game represents a system of programs and their informational content, created for the purpose of organizing the Game Process and its functioning on User devices, consisting of:

Applications understood in the present Agreement as a software required for the Video Game to function on the following User devices:

- portable (mobile) devices connected to the Internet running either iOS or Android operating system, installed or downloaded by the User on such devices using the Google Play service (Google Inc.) and/or the Apple Store service (Apple Inc.);
- on personal computers connected to the Internet running either macOS or Windows operating system, installed or downloaded by the User on such devices using the Apple Store service (Apple Inc.) and/or Microsoft Store (Microsoft Corporation), or using an installation file downloaded from the Website, or obtained from online publishers or distributors of software, applications or games;
- on game consoles of various brands providing applications and game distribution services on their platforms (the list is open).

Game Content refers to the collective informational content of a video game (text, audio works, sounds and video images, graphic images, animation, pictures, 3D objects, and other information) obtained by the User during the gaming process.

Gameplay is a component of a video game responsible for the interactive interaction between the game and the User, allowing Users to interact with the game and with each other through the implemented Software part of the gameplay mechanics process.

Game Mechanics refers to a set of rules, methods and parameters that enforce certain modes of interaction of users with the Video Game and each other, manifested through a multiplayer game taking place in a virtual world where users can immerse in the experience of car racing, feel the thrill of driving various kinds of cars and tuning/upgrading/collecting them, compete with each other for achievements, prizes or Project Tokens, purchase/earn/use Project Tokens, as well as amass/upgrade/purchase/collect/use Project Tokens for the goals determined by the Game Process.

Google Play Service refers to Google Play Games Services provided by Google Inc., which is designed to enable Users to Register and Login as subjects of the Game Process in the Video Game with the help of the Mobile Application using the Android software platform provided by Google Inc., as well as to store, process and transfer numeric and text data, gather analytics, and implement other features envisioned by the service.

App Store Service refers to the Game Center Service provided by Apple Inc., which is designed to enable Users to Register and Login as subjects of the Game Process in the Video Game with the help of the Mobile Application using the iOS software platform provided by Apple Inc., as well as to store, process and transfer numeric and text data, gather analytics, and implement other features envisioned by the service.

Web Portal is a system of programs, websites, and third-party services designed to facilitate and organize the process of information interaction (including editing, management, etc.) through its software component.

Website is a system of programs and a set of logically interconnected web pages located at <https://action.myriadgames.studio/>, serving as an interface designed to provide Users with access to the Products and Services.

Content is a set of information content (photos, videos, audio recordings, texts, 3D models, articles and images), as well as any other information materials owned by their relevant Copyright Holders and used by Myriad Studio or the Administration for the purpose of posting them in the Product and/or on other resources (Project's Social Media) in order to organize the work of the Services and promote the Product.

Database is a shared set of logically related data collected and created during the operation of the Product (along with a description of said data), the totality of which is stored in accordance with the data scheme and rules developed on the basis of programming languages, which is designed for storing, systematizing, processing information and meeting data needs for the proper operation of the Product.

Crypto Vault is a software unit of the Product created or developed by the Initiator based on Blockchain technologies to allow the use of Smart Contracts and/or Crypto Assets, both in the process of Project development and creation and in the process of Project improvement and maintenance, provided to Users and other persons on the terms established by the Initiator and/or Owner of the Smart Contract and managed during its operation by the Smart Contract Operator for the purposes provided for by the Game Mechanics, rules, policies, public or non-public contracts/agreements concluded with/between users and/or other persons.

Blockchain is an information network (distributed data storage system) with a logical structure (nature) created (coded) on the basis of mathematical formulae according to specific rules and algorithms, which comprises information recorded in such a network regarding reliable (verified through a format and signature check) Transactions sequentially connected and recorded in groups of multiple Transactions stored within a special structure (block) linked continuously to a chain of similar blocks (linked registry), which does not only provide interconnection between blocks through enumeration, but also stores hash sum data for the interconnected blocks, and, as a result, stores the entire information about all transactions/operations ever performed therein.

Crypto Assets are, in this agreement, interchangeable tokens/coins and/or non-fungible tokens (NFTs) and recognized as a set of electronic data (digital code or designation) contained within a Blockchain information system, which are offered and/or may be accepted as a means of payment/exchange between their holders, not being the monetary unit of any state and/or official international monetary, or official accounting unit, and with respect to which there is no entity obligated in any way to each holder of such electronic data, except for the Smart Contract Operator and/or information system nodes, obligated solely to ensure compliance with the procedure for issuing such electronic data and/or taking actions with respect to them by making (changing) records in such information system or managing such a system in accordance with its rules and the embedded logic of the Smart Contract.

Project Tokens are Crypto Assets issued by the Smart Contract Initiator as service (user) tokens providing their owners with the opportunity to access the Crypto Services of the Product and/or use them in ways provided for by the logic of Smart Contracts in the Services.

Smart Contract is a software code consisting of functions and methods created (coded) in the Blockchain according to a specific algorithm and intended for recording, managing and exchanging Crypto Assets and information data through Transactions, recording data in the Blockchain or performing calculations and/or other actions within the limitations of its inherent logic.

Crypto Account is a logical structure recorded in the Blockchain which represents a Public Address consisting of 40 hexadecimal characters generated based on a Private Key consisting of 64 hexadecimal characters and is required for carrying out Transactions.

Transaction is a method of recording information in the Blockchain carried out by a Crypto Account on behalf of its Public Address with mandatory confirmation/approval/signing of such recording with a Private Key, through which an electronic signature is generated for the amount of data included in the transaction, which is subsequently verified by network nodes before recording the changes to the data register of the corresponding Blockchain.

Crypto Wallet is an electronic system for generating and/or storing and/or directly using the Private Key address for carrying out Transactions, which uses a system of cryptographic encryption algorithms and passwords that ensure uniqueness and security of data access, as well as the possibility of backing up and restoring access to such data in the event of device loss or damage.

Smart Account refers to the Smart Contract linked to the User Account created for the purpose of recording the User's various interactions, storing the User's in-game Project Tokens, and carrying out Transactions.

Smart Account refers to the Smart Contract linked to the User Account created for the purpose of recording the User's various interactions, storing the User's in-game Project Tokens, and carrying out Transactions.

Exchange rate is a ratio between Crypto Assets established by agreements and/or Smart Contract logic that governs the amounts of Crypto Assets due for transfer and receipt between the parties in the form of a set ratio that can be expressed as an integer number, a decimal fraction or other mathematical ratio.

Exclusive Rights are rights to the results of intellectual activity and means of individualization equated to them in relation to the Product and all of its derivatives, Content, logo and/or trademark (commercial designation), which constitute a property right subject to protection in accordance with international law (International Convention of July 24 1971 "The Berne Convention for the Protection of Literary and Artistic Works").

Simple (Non-Exclusive) License is the User's non-transferable, non-exclusive, revocable, limited right to use and access the Product and the Service for personal and non-commercial use provided to the User by Myriad Studio on a paid and/or free-of-charge basis, including rights for the use of the Product and, respectively, its Services within the limits stipulated in the terms of the User Agreement and/or license agreement and/or other agreements/transactions concluded in the form of an offer or in any other legal way between the Parties, whereby Myriad Studio retains

Registration is a set and sequence of actions provided for by the Product Services that the User performs in order to create an Account or gain access to certain sections of the Product and its Services.

Authorization is a set and sequence of actions provided for by the Product Services that the User performs in order to gain access to the Account after completing the Registration procedure.

Authentication is a set and sequence of actions provided for by the Product Services that the User performs in order to confirm their authenticity during Authorization and/or for the purpose of additional confirmation/authorization of operations performed by the User.

Account is a set of User credentials and game data required by the User to perform Authentication and receive access to the Services.

Personal Data is personal information about the User and/or information directly or indirectly related to a certain User, which is processed by Myriad Studio and/or third parties with the voluntary and/or informed consent of the User when using the Services for the purposes provided for by the User Agreement, including those provided for in the PRIVACY POLICY section.

1. CONCLUSION OF THE USER AGREEMENT

This Offer is considered accepted by the User/Acquirer/Smart Contract Participant, and the User Agreement between Myriad Studio and the User is considered concluded from the moment of Acceptance of the Offer.

The conclusion of the User Agreement is carried out in accordance with the terms of the current version of the User Agreement, posted on the Internet at https://action.myriadgames.studio/documentation/user_agreement/ at the time of Acceptance. If the User uses the Services after a new version of the User Agreement (located in the relevant section of the Website or in the Video Game) comes into force, it shall mean that the User fully agrees with it, and all its provisions fully apply to them.

The User Agreement may be changed by Myriad Studio at any time without any special notice to the User. The new version of the User Agreement comes into force from the moment it is posted in the relevant section of the Website or Video Game, unless the new version expressly states otherwise. Regular familiarization with the current version of the User Agreement is the responsibility of the User.

The current version of this User Agreement is available in the relevant section of the Website or Video Game.

Should any provision of the present Agreement be, for any reason, held to be invalid or unenforceable, the other provisions of the present Agreement shall remain in effect and the invalid or unenforceable provision shall be deemed modified so that it is valid and enforceable to the maximum extent permitted by law.

The present terms and conditions, as well as the rights and obligations of the User hereunder, may not be transferred, assigned, sold, subcontracted, delegated or otherwise transferred by the User without the prior written consent of Myriad Studio, and any attempted assignment, sale, subcontract, delegation or transfer to violation of the above shall be considered void.

Myriad Studio may freely dispose of, assign, sell or delegate its obligations and rights arising from the present Agreement to Affiliates and/or third parties without the prior consent of Users. The terms and conditions set forth in this Agreement shall be binding upon said transferees.

3. GENERAL PROVISIONS

Myriad Studio offers the **User** the opportunity to access and use the **Product** and the available **Services** under the terms and conditions of this **User Agreement**. Additional terms, rules, and restrictions may apply to the use of certain Services of Myriad Studio, which the User may review at: https://action.myriadgames.studio/documentation/user_agreement/. Myriad Studio reserves the right, at any time and at its sole discretion, to revise or amend the terms and conditions of the Services, to supplement, modify, limit, or expand the functionality of the Services, including the terms of User access to the Services or to certain features of the Product.

The Services are provided to the User on a **free-of-charge and/or paid basis**, depending on the functionalities of the Product selected by the User, including but not limited to: the **Website**, the **Video Game**, or the **Crypto Service**. The terms for free use of the Service's functionalities are established by this User Agreement. If the User does not agree with, or fails to comply with, the provisions of this User Agreement, the User is **not entitled** to access or use the Service and/or the Product. Myriad Studio may, at its sole discretion, **suspend or terminate** (temporarily or permanently) the provision of the Services (or any specific features thereof) to all Users or to any individual User, without prior notice.

The Services may rely on or incorporate **data, services, or licenses of third-party providers**.

This User Agreement applies to the Product and all existing functionalities of its Services, as well as to any future developments, updates, or additions thereto.

The User acknowledges and agrees that nothing in this User Agreement shall be construed as establishing any relationship between the User and Myriad Studio other than those expressly provided for herein.

The User hereby confirms that they possess sufficient technical knowledge necessary to access and use the Services, including knowledge of hardware and software requirements, and that they have all necessary technical means to use the Services.

The User further acknowledges and understands that certain **graphic, sound, and/or video materials** included in the Services may, under certain circumstances, cause exacerbation of **neurological or psychological disorders** in individuals susceptible to such conditions. The User represents that they do not suffer from such disorders or, if they do, undertake to refrain from using the Services.

The User shall cease using the Services for a prolonged period if continued use may result in harm to their **physical or mental health**.

4. GENERAL PROVISIONS ON ACCESSING PRODUCT SERVICES

The User can start using the Entertainment Service and the Application features after installing the Application on their device and completing the Registration and/or Authorization and/or Authentication procedures using the Service Tools.

The User can begin to use the Information Services and Website features by following the appropriate link and interacting with its interface. Certain Services and Website features (Payment Service, Crypto Service and so on) only become available to the User after their Registration and/or Authorization and/or Authentication using the Service Tools.

During Registration, the User must provide credentials that are required by the relevant Services for Registration and/or Authorization and/or Authentication.

Personal identifiers, such as phone number and/or email address and/or Public Address of the Crypto Account, etc., which are required for the Services to perform a Registration of a separate Account with a subsequent Authorization and/or Authentication, must be unique for each User. Using the same personal identifiers by different users is not allowed. Users can change their Account data as long as such functionality is provided by the Services.

In order to access the Services, the User undertakes to provide accurate and complete information on all queries made during the Registration, which is necessary for Myriad Studio to fulfill its obligations. The User undertakes to keep this information relevant.

The User is obliged to monitor the safety of their credentials and not to disclose them to any third parties. The User is not entitled to transfer their credentials to third parties, as well as directly or indirectly allow third parties to use the User's credentials for Authorization purposes.

The User shall be solely responsible for ensuring the security (resistance to guessing) of their chosen password, as well as the safekeeping of their login, password, e-mail data and the Crypto Account used. The User shall be held solely responsible for all actions (along with their consequences) related to their use of the Services under their User Account, including cases of voluntary or non-voluntary surrender of the User Account access data by the User to third parties.

Any action performed from within the User's Personal Profile and/or using their Credentials is considered an action performed by the User themselves and imposes duties and responsibilities on the User in relation to such actions, including all liability for violation of the present User Agreement.

Users are obliged to change the credentials immediately if they have reason to suspect that the credentials have been disclosed, or can be otherwise used by third parties not authorized by them, or when asked to change them by Myriad Studio.

Myriad Studio has the right to use any technical means available to verify the validity of the information provided by the User when using the Services. Myriad Studio cannot guarantee that the identity of any given User corresponds to that User's claims thereto and cannot be held responsible for any discrepancies, as well as cannot guarantee that any information provided by the Users of the Service is accurate.

The User can delete their Account using the appropriate Service Tools. Deleting an Account does not imply completely deleting the User-related information contained in the Databases; instead, it only means terminating the User's ability to use their Account for Authorization and use of the Services. According to the general rules, after initialing the procedure of Account deletion, the User can restore it or permanently delete it without the possibility of recovery by contacting the Service Desk with a corresponding request within 365 days of initial deletion. Once this period is over and no recovery request has been made, the Account is permanently deleted and cannot be restored.

Myriad Studio has the right to unilaterally deny any User access to their Account and/or their Personal Profile. Myriad Studio has the right to terminate/block and/or restrict any User's access to the Services at any time, as well as block or delete User Accounts on the Service without an opportunity of recovery, as well as prohibit access from any Account to any specific Services and features of the Services and remove any content or information without explanation and unilaterally at its own discretion, including when the User infringes on the terms of the User Agreement and/or a separate license agreement and/or any other agreement/transaction concluded in the form of an offer or otherwise legally between Myriad Studio and the User, or without such infringement. The infringement of the terms of agreements and/or legislation by the User is established by Myriad Studio in a unilateral and independent fashion. The User hereby agrees to this procedure and undertakes to comply with any such decision made by Myriad Studio.

In order to anticipate or prevent violation of the User Agreement and/or damage to the Products (for example, from DDoS attacks or other hacker attacks, use of software unauthorized by Myriad Studio, including when used by the User to upload, post, or download information, etc.), the Administration has the right to restrict access of the User or any third parties to the Product and/or Services by blocking access from the relevant IP address or ranges of IP addresses.

Registration is not required for viewing information posted on the Service in the public domain, however, when such actions are performed from a mobile device, personal computer, mobile phone, smartphone, tablet or other device of the User, they are considered actions performed by the User themselves, and entail the same obligations and consequences for the User as if they themselves performed these actions.

Myriad Studio provides Users with round-the-clock access to the Services, except for maintenance downtimes and other circumstances that may prevent the use of the Services. Such circumstances include, but are not limited to: the User's lack of Internet access, the User's failure to maintain the necessary technical infrastructure in error-free condition, and others.

Myriad Studio shall not be held responsible for any possible loss and/or damage to data arising from the User's violation of the provisions of any agreements/transactions concluded by the Parties, as well as improper access to and/or use of the Services, or any technical failures.

Myriad Studio has the right to monitor and/or record Users' communications as they use the Services, and the User hereby acknowledges and agrees that when using the Services, they have no expectation of confidentiality of their communications. Myriad Studio reserves the right to disclose User communications for any reason, including:

- to satisfy any applicable law, regulation, judicial process, or government agency request;
- to ensure compliance with the terms of the present User Agreement or the Privacy Policy;
- to protect Myriad Studio's legal rights and remedies;
- to protect the health or safety of any person who Myriad Studio believes may be at risk;
- to report crimes or other offensive behavior;

By accessing the Service, the User agrees to receive advertising information posted on the Service by Myriad Studio and/or third parties. The User understands and agrees that Myriad Studio does not determine the content and is not responsible for the information posted by third parties, including websites that may be linked to in the relevant materials.

Myriad Studio has the right to independently, unilaterally and at its own discretion determine the conditions and/or procedure under which Users shall pay for individual or paid Services, including, but not limited to: the conditions, procedure, and methods of payments effected by Users between themselves and Myriad Studio. Changes to the aforementioned conditions may be set forth in the relevant agreements or posted/changed on the Services themselves.

The use of software that allows viewing or posting information on the Service bypassing the usual procedure for posting information (for example, using software for automatic upload of information) in the absence of written permission from Myriad Studio is strictly prohibited and may lead to termination and/or suspension of the publication of information, as well as blocking access to the Services.

The Services are not intended for use by persons under 18 years of age or other age provided for by the laws of the country of citizenship/affiliation/residence of the User, as long as there is an age requirement for some of the Services. Myriad Studio does not knowingly collect information about the age of the User, including personal information from children under 13 years of age. Therefore, restrictions on the access of such persons to the Product and/or its Services are carried out by the User themselves or their legal representative. If the User is under the age of 13 or has not reached the age necessary to use the Product and/or its Services provided for by the laws of the country of citizenship/affiliation/residence of the User, they are obliged to stop all use of the Product and/or its Services. The use of the Services by persons who are under the age of 13 or another age provided for by the laws of the country of citizenship/affiliation/residence of the User means that they act with the consent and/or approval of their legal representative, with the latter bearing all the legal consequences of such use.

The User's requests to Myriad Studio about issues related to the use of the Services are considered in the manner provided for on the relevant Service or by e-mail: support_action@myriadgames.studio.

Myriad Studio reserves the right to, but shall not be held liable for mediating disputes between Users in any manner whatsoever.

Myriad Studio has the right not to consider the User's requests when they: do not contain information and documents necessary for consideration of the request; contain false information and (or) documents that have signs of being inauthentic; are related to issues on which Myriad Studio has previously sent a response to the User (repeated requests); contain insults, threats or requests stated in a highly expressive manner; are sent in violation of other terms and the procedure for consideration of requests provided for by Myriad Studio.

5. GENERAL TERMS OF ACCESS TO PAID OR RESTRICTED RESOURCES

Mandatory Registration and/or Authorization and/or Authentication on the Service followed by a payment for the Paid Services, in the manner and to the amount specified by the Payment Service or Crypto Service or the terms of a separate agreement/contract provided by Myriad Studio are all considered prerequisites for the User to obtain access to, and the features of, Paid Services.

Obligations of Myriad Studio to provide access and features of Paid Services to the User are counter to the User's own obligations to pay for or perform actions specified by the Service as stipulated in the present User Agreement and/or the terms of a separate license agreement and/or other agreement/transaction concluded in the form of an offer or otherwise legally between the Parties. In the event that the User fails to comply with these obligations, Myriad Studio may suspend the User's access to the features or functions of Paid Services in whole or in the relevant part.

Myriad Studio provides the User with the access and features of Paid Services as long as there is a possibility to do so, which is determined, among other things, by the User's compliance with the rights and obligations established by the present User Agreement and/or other agreement outlining rights and obligations. Due to the need to comply with the rights and obligations set forth in the agreements between the Parties, wherein normal functioning of the Services is impossible without said compliance, the User hereby recognizes that their failure to comply with their obligations may lead to Myriad Studio being unable to fulfill its own obligations with regard to providing access to the aforementioned resources.

Due to the nature of the Paid Services offered by Myriad Studio and aimed at meeting the individual needs of the User, Myriad Studio shall not be obliged to provide access to Paid Services to all parties requesting it, and may refuse to provide access to the User if such provision fails to comply with the requirements outlined in the present User Agreement and/or the terms of a separate license agreement and/or other agreement/transaction concluded in the form of an offer or otherwise legally between the Parties, including their subject matter and so on.

The terms for providing specific Paid Services, including their content, volume, availability periods and pricing, payment procedures, rights and obligations of the Parties, shall be determined both by the terms of the present User Agreement and/or the terms of a separate license agreement and/or other agreement/transaction concluded in the form of an offer or otherwise legally between the Parties, and any other conditions, rules and requirements posted on/set forth in the interface of the relevant Service.

All Paid Services are subject to change, amendment, and updates, and therefore they are offered for use on the “as is” basis, that is, in the form and to the extent that they are provided by Myriad Studio at the moment the User accesses the relevant Paid Services.

Myriad Studio has the right to use the contact details specified in the User Account to send the User notifications via email related to the execution of concluded transactions, including notifications about the statuses of any Paid Services being provided, as well as renewal methods and other informational messages.

When using Paid Services, the User undertakes to comply with the requirements set forth in the provisions of the User Agreement and/or other agreement, the relevant terms of their selected Service(s), and any instructions provided in the interface of the Paid Service.

At the request of Myriad Studio, the User is obliged to provide any information or documents necessary to identify the User as a party to the agreement in the event that the User sends claims, requests or other queries to Myriad Studio related to the provision of Paid Services. Furthermore, Myriad Studio has the right to verify the identity of the User as a party to the Agreement on its own by verifying the information specified by the User in their Personal Profile on the Service, and compare their details with payment details under the Agreement.

The costs applicable to any Paid Services chosen by the User when using a Payment Service as a payment method shall be determined based on their parameters (type, package contents and other Paid Service characteristics), and shall be reported to the User in U.S. dollars or other currency and other conditions through the user interface when an order or application is made, unless otherwise provided for by the terms of the relevant Service.

The costs applicable to any Paid Services chosen by the User when using a Crypto Service as a payment method shall be determined based on their parameters (type, package contents and other Paid Service characteristics), and shall be reported to the User in the form of the required Crypto Assets and conditions through the user interface when an order or application is made, unless otherwise provided for by the terms of the relevant Service.

What payment method and procedure the User shall use when paying for the Paid Services provided by Myriad Studio shall be determined depending on the specific Paid Service(s) chosen by the User in the manner established by such Service, including: non-cash transfer of funds to Myriad Studio from payment cards, payment to the current account against the issued billing documents (invoices), payment through a payment service and/or bank chosen by the User, and/or a Myriad Studio partner bank; payment involving another legal entity (agent); by means of a Crypto Asset Transaction.

Myriad Studio has the right to instruct/authorize its Affiliates or other legal entities based on agreements concluded with them to accept payments for any Paid Services, whereby the payments made by the Users to such companies shall constitute proper fulfillment of their obligations to Myriad Studio.

All payments or other transactions shall be carried out using the established payment methods.

The fact of providing the User with access to specific Paid Services and their respective extents shall be determined based on the statistical data accumulated by the Myriad Studio accounting system.

It is agreed by the present Parties that in relation to any monetary obligations of Myriad Studio to Users arising in connection with the receipt of funds or other means for the use of Paid Services, no legal interest (interest on the amount of debt for the period of use of funds) is charged.

6. CLAUSE ON CRYPTO SERVICES

In order to introduce Crypto Services into the Product, it is developed using Blockchain technology.

Crypto Services allow the Product and its Users to use Smart Contracts, Crypto Assets, and Project Tokens.

More details about the Project's Crypto Assets and their practical functions can be found in the Product Whitepaper.

Myriad Studio independently defines the Crypto Architecture of the Product, as well as the different types and methods in which Blockchain Networks are used, including: during the development, improvement and operation of the Product or its individual units; the logic of Smart Contracts; the types and logic of the Crypto Assets and Project Tokens used.

Unless otherwise established by a separate provision or follows from the essence of the obligations or agreements between Myriad Studio and Affiliates and/or third parties, Myriad Studio is the Smart Contract Initiator and/or the Smart Contract Operator and/or the Smart Contract Owner in relation to the Crypto Services and Project Tokens.

Myriad Studio has the right, at its discretion and without the prior consent of the User or other persons, to transfer the powers and certain functions of Smart Contract Initiators, Smart Contract Operators, and Smart Contract Owners to Affiliates or third parties on the basis of a contract/agreement and/or other obligations.

Crypto Services enable Users to use Crypto Architecture for various purposes, including:

- using a Smart Account to record and manage their in-game assets;
- using a Crypto Account to account for and manage external game assets;
- using Smart Contracts for relevant Transactions;
- purchasing and exchanging their Crypto Assets for Project Tokens and back if provided for by existing conditions;
- using and disposing of Project Tokens in accordance with their purpose or at their own discretion insofar as this is provided for by the logic of Smart Contracts and the rules of the Video Game;

The rules for the acquisition and/or exchange of Crypto Assets or Project Tokens, including the Exchange Rate and other conditions, are specified/established by the logic of Smart Contracts or separate agreements, or published in the relevant sections of the Product Services.

7. GAME ACTIVITY

Myriad Studio independently determines the policies of the Game Process, as well as the conditions and essence of the Game Mechanics and Game Content.

The main conditions of the Video Game's Mechanics are implemented through a Game Process, which becomes available to Users based on their fulfillment of certain game requirements.

The Administration has the right, but is not obligated, to provide up-to-date information about the Game Process by informing Users on the Website; it will strive to update data on the Project in a regular manner.

When interacting with Users, the Administration acts on behalf of Myriad Studio, informing Users through the Services and Project's Social Media about any changes and news, and also processes requests based on claims received from Users.

Myriad Studio has the right to hold competitions, sweepstakes, events and incentives among Users.

The conditions for holding such events, as well as the forms of rewards, shall be determined by Myriad Studio or its partners (sponsors) at their own discretion.

The User agrees, by accepting the relevant prizes and awards, whatever form they may be expressed in, that they are legally entitled to do so and have no legal restrictions imposed on such actions.

Content created by Users including any data, information, photos, videos, recordings or files that they upload, transfer to the Administration or enter into the Services and/or that the Users otherwise send to Myriad Studio when participating in competitions or sweepstakes (hereinafter referred to as the User's Creative Content) is considered included in the broader definition of Content, whenever applicable.

By participating in the Creator Program, the User acknowledges and agrees that Myriad Studio will transfer and process their Personal Data electronically.

Information created and/or distributed by Users including avatar content, User's name, as well as any text, photo, video and audio information distributed on the Services or the Project's Social Media, including in private or public chats, forums, and channels, shall hereinafter be referred to as User Content.

The User shall be solely responsible for creating and maintaining their own backup copies of User Content if they so choose.

8. PRIVACY POLICY

By entering into (accepting) this User Agreement via the direct use of the Product and its Services, acting freely, by their own will and in their own interest or in the legitimate interest/representation on behalf of the User and/or on consent/approval of the legal representative, as well as confirming their legal capacity, the User agrees and accepts the terms of the Privacy Policy (hereinafter referred to as the Policy) in relation to Personal Data, laid out in this User Agreement and in this section.

The policy laid out in this section of the User Agreement determines: types of Personal Data, methods of obtaining Personal Data, actions performed with Personal Data, the purposes of processing Personal Data, methods of protecting Personal Data, legal grounds for processing Personal Data and other terms regarding processing Personal Data used by Myriad Studio and third parties processing Personal Data.

The processing of Personal Data means any action (operation) or a set of actions (operations) performed with Personal Data provided for by this User Agreement, including:

7	Analysis	the process of researching, filtering, transforming and modeling Personal Data in order to extract useful information and make decisions based on it.
8	Clarification	the process of changing (updating) Personal Data
9	Use	the process of utilizing Personal Data for the purposes provided for in the User Agreement.
10	Depersonalization	the process that makes it impossible to establish a connection between Personal Data and a specific User without resorting to additional information.
11	Blocking	temporary suspension of processing Personal Data (except when processing is necessary to clarify Personal Data).
12	Transfer	the process of transferring Personal Data from their place of storage to a third party in the form of a digital bitstream by means of telecommunications over a data transmission channel, by exchanging the data, copying, distributing them, providing access to them for subsequent processing by means of computer technology.
13	Cross-border transfer	the transfer of Personal Data to the territory of a foreign state, to the authorities of a foreign state, to a foreign individual or a foreign legal entity.
14	Provision	actions aimed at the transfer of Personal Data to a specific party or parties.
15	Disclosure	actions aimed at the transfer of Personal Data to any number of unspecified parties.

16	Destruction	a sequence of actions and operations using software or hardware tools, including physical destruction of physical storage media intended for the irreversible deletion of Personal Data, as a result of which such data is destroyed irrevocably, making it impossible to restore their content.
Myriad Studio and third parties process the User's Personal Data if they are filled in and/or sent by the User on their own via special forms located on the Services and/or obtained with the consent/approval of the User from third-party resources (social media, etc.) where the User is registered or which they use (if it is provided for by the functionality of the Service), and/or directly from the User using feedback forms and/or received with the consent/approval of the User automatically in the form of data (information) from the devices and software used by the User. Myriad Studio processes the User's Personal Data automatically only, using computer equipment and software. In its work, Myriad Studio strives to use modern, up-to-date and at the same time reasonable methods and means utilized in informational, technological and technical systems for processing Personal data. Myriad Studio does not collect or process special categories of Personal Data related to the User's age, race, nationality, political opinions, religious or philosophical beliefs, medical status, personal life, as well as biometric Personal Data that characterizes the physiological and biological characteristics of the User which can be used to identify them. The Services are not intended for use by persons under 13 years of age or other age provided for by the laws of the country of citizenship/affiliation/residence of the User. Myriad Studio does not knowingly collect Personal Information about the age of the User, including personal information from children under 13 years of age. In the event that Myriad Studio discovers that a child under the age of 13 provides Personal Data or personal information, Myriad Studio immediately deletes it. If the legal representative (parent or guardian) is aware that a person under the age of 13 or other age of legal capacity has provided Personal Data or other personal information, they may contact Myriad Studio so that the necessary steps can be taken. Myriad Studio strives to ensure that the Users' interaction with the Product and Services is as informative as possible and meets the interests of the Users. Therefore, Myriad Studio considers it important to notify Users that Myriad Studio and third party service providers (services) with which Myriad Studio cooperates (such as Google Analytics by Google Inc. and Adjust) process or may process Cookies and similar technologies and that the User needs to know which Cookies are processed and for what purposes. This will help toward protecting the User's Personal Data. More information about the processing of Cookies can be found in this section and in the COOKIE NOTICE section of this User Agreement. In the process of processing Personal Data, Myriad Studio uses a specialized external third-party Google Analytics service by Google Inc. to analyze the actions of Users on the Services. This information is provided to Myriad Studio from the Google Analytics service in the form of Anonymized Data, and is processed by Myriad Studio for the purposes provided for by this Policy. Myriad Studio recommends that the User independently familiarize themselves with the terms of service of Google Analytics and the technologies used by Google Inc. when collecting and processing Personal Data of the Subject (https://policies.google.com/technologies/partner-sites), including Cookies (https://policies.google.com/technologies/cookies), and their obligations to protect privacy and security of the data obtained through the Google Analytics service, as well as the ways to manage one's privacy modes (https://support.google.com/analytics/answer/6004245). In its processing of Personal Data, Myriad Studio uses a dedicated third-party analytics service called Adjust by Adjust GmbH to analyze the Users' actions across its Services. Adjust transfers this information to Myriad Studio in the form of Anonymized Data and is processed by Myriad Studio for the purposes provided for in the present Policy. Myriad Studio suggests that the User familiarize themselves with the terms and conditions of the service provided by Adjust, as well as the technologies used by Adjust to collect and process Personal Data https://www.adjust.com/security/, including Cookie Files and their obligations to protect the confidentiality and security of the data collected by the service https://www.adjust.com/terms/privacy-policy/, as well as the options provided to the User for managing their confidentiality mode https://www.adjust.com/forget-device/. The table below describes the categories and types of Personal Data, as well as the purposes of collecting and processing Personal Data performed by Myriad Studio or third parties when the User uses the Product and/or its Services. In the process of making a payment or other transaction through the Payment Services, Crypto Services or other third-party resources offered by Myriad Studio as a payment or transaction tool, the Payment Service or other resource may process Payment Information or other information provided by the User for the purposes provided for in this Policy and/or other information on the terms and for the purposes provided by the service.		

Under certain circumstances and when dictated by the law or the requirements of a third-party Service, for the purposes of passing KYC/AML procedures, the Administration or a third-party service may require the User to provide additional personal information, including Personal Data not described in this section.

Depending on the country/region, legislation and technical availability, Myriad Studio may choose to use the services of different Payment Services, therefore, it is recommended that the User independently familiarize themselves with the terms of the Payment Service proposed to them, the technologies used by said service, the legal bases it operates on when processing payments, the matters of collection and processing of the User's Personal Data, and their obligations to protect the confidentiality and security of data received through their Payment Service. Users are encouraged to analyze the information received and reach their own decision on whether to use or not to use the suggested Payment Service.

Myriad Studio never processes the User's Payment Information in its normal operation, except for information received from the Users in relation to their placed orders, and information from the Payment Services about any completed or rejected transactions carried out by the Users in relation to specific orders.

The table below describes the categories and types of Personal Data, as well as the purposes of collecting and processing Personal Data performed by Myriad Studio or third parties when the User uses the Product and/or its Services:

In view of the availability of the Product and/or its Services in different regions and countries and the need for decentralized management of information databases related to the Product, Myriad Studio has the right to entrust the			

processing of Personal Data to its Affiliates, while these companies are obliged to comply with the principles and rules for the processing of Personal Data provided for by this User Agreement and/or separate license agreements and/or other agreements/contracts concluded with the User in the form of an offer or in another legal way as well as the laws of the country of registration of these companies.

Myriad Studio and its Affiliates have the right to process Personal Data personally or entrust the processing of Personal Data to a third party, based on a contract concluded with that third party or on other legal grounds. The third-party processing Personal Data on their behalf is obliged to comply with the principles and rules for the processing of Personal Data provided for by this User Agreement and federal laws. Myriad Studio's instructions to this third party must define: a list of actions (operations) with Personal Data that will be performed by the third-party processing Personal Data as well as the purposes of processing, the obligation of such a third party to maintain the confidentiality of Personal Data and ensure the security of Personal Data during their processing. 2. CONSENT TO PROCESSING OF PERSONAL DATA

Entering into (accepting) this User Agreement via direct use of the Services, viewing information, etc. including, but not limited to: the Product, the Web Portal, Services and feedback forms, acting freely, by their own will and in their own interest or in a legitimate interest/representation on behalf of the User and/or consent/approval of a legal representative, as well as confirming their legal capacity to conclude the User Agreement, the User accepts these terms and gives their unconditional consent to Myriad Studio to process their Personal Data, as well as any other information provided by the User and/or received by Myriad Studio, on the terms provided for by this User Agreement, including PRIVACY POLICY and COOKIE NOTICE sections.

This consent is valid for the entire period of time necessary to achieve the Purposes of Personal Data processing or until the User revokes their consent by sending a written request to Myriad Studio by email: support.action@myriadgames.studio.

The User has the right to request the deletion of their Personal Data, as provided in the PRIVACY POLICY section, by sending a corresponding request to the Administration via email at: support.action@myriadgames.studio. Within 7 days after processing such a request, the User's Personal Data will be deleted, except for data that must be retained in accordance with applicable law.

11. USER RIGHTS AND RESPONSIBILITIES

The User has the right to:

- use the Product and the functionality of the Services for the purposes provided for by the Services in accordance with the terms of this User Agreement and/or the terms of a separate license agreement and/or other agreement/contract concluded between the Parties in the form of an offer or in another legal way;

- to the best of their knowledge, there are no unresolved legal issues, threats of litigation or other circumstances that may have negative consequences for the party to the User Agreement or its activities, the party to the User Agreement has not violated any material provisions of any contract or other agreement concluded by it, there are no rulings and decisions of the court, arbitration court or other state agency that may have a negative impact on the position of the party to the User Agreement or its activities;
- there are property-related obligations and no provisions in legislation or other regulations, in contracts binding on a party to the User Agreement that may violate or prevent the signing or execution of the User Agreement;
- fulfillment of obligations under the User Agreement is an unconditional obligation of the party to the User Agreement, which has at least the same priority as other obligations of the party to the User Agreement;

Users acknowledge and agree that, in their relationship with Myriad Studio as a User, they are not employees or independent contractors of Myriad Studio for any purpose, and their relationship, among other things, is not subject to any employment or labor standards laws or regulations on workers' compensation, as well as any provisions adopted in accordance with such provision, including participation in the company capital.

Users are not and will not represent themselves as agents, joint venturers, partners, officers, directors or employees of Myriad Studio. Approved Creators agree not to make any representations or engage in any activities that would create an apparent agency, joint venture, partnership or employment relationship with Myriad Studio without the latter's written approval.

The User is solely responsible for their User Content and Creative Content distributed on the Services or Social Media of the Project. The User assumes all risks associated with the use of User Content, including any reliance on its accuracy, completeness or usefulness by others, including if the User Content/Creative Content exposes the identity of the User or any third party. The User hereby represents and warrants that their User Content shall not violate this Agreement.

The User may not represent or warrant to any third party that their User Content is in any way provided, sponsored or endorsed by Myriad Studio.

13. LIMITATION OF LIABILITY

Myriad Studio does not bear any responsibility for any direct and/or indirect consequences of any use or inability to use the Services and/or losses (including real damages, lost profits) caused to the User and/or third parties as a result of any use, non-use or inability to use the Product and/or Services or their individual components and/or functions, including the cases when it happens due to possible errors or malfunctions of the Services.

To the maximum extent permitted by law, Myriad Studio shall not be held responsible to the User or any third party under any circumstances for any lost profit, lost data or any indirect, subsequent, approximate, random, special or penalty loss (including bodily harm, death and material damage) that arose as a result of the use of Services, even if Myriad Studio was aware about the possibility of such damage. Access to the Services and their use is carried out at the User's own discretion and risk, and the User shall carry the sole responsibility for any damage incurred to the User's devices or computer systems or any loss of data resulting therefrom. The User acknowledges and concedes that:

All purchases of Project Tokens or in-game currency on the Services shall be considered final, and Myriad Studio shall not issue refunds.

Purchases of Crypto Assets carried out through third-party Payment Services or Payment Service Providers or via the Apple Store or Google Store shall be regulated by the refund policy of the corresponding third-party service provider(s).

16. PERIOD OF VALIDITY OF THE USER'S AGREEMENT

This User Agreement shall enter into force upon the User's **Acceptance of the Offer** and shall remain in effect until **terminated by either Party** or until it otherwise ceases to be effective.

The User shall have the right, at any time and at their sole discretion, to **unilaterally and extrajudicially terminate** this User Agreement by completely ceasing to use the Product Services, provided that such use is carried out without registration.

At any time, **Myriad Studio** shall have the right, at its sole discretion, to **unilaterally and extrajudicially terminate** this User Agreement by **fully blocking the User's IP address**.

All disputes arising under the present Agreement shall be referred to the court in accordance with the territorial jurisdiction at the location of Myriad Studio. For Services provided by Affiliates, their respective jurisdictions shall apply. The User agrees that the courts of such jurisdictions have exceptional jurisdiction to resolve any disputes or claims arising in connection with the subject or the formulation (including non-contractual disputes or claims) of provisions in the present Agreement.

The recognition of certain parts of the present User Agreement as invalid shall not cancel the effect of other provisions of this User Agreement.

Inaction on the part of Myriad Studio in case of violation of the provisions of the User Agreement by the User does not deprive it of the right to take appropriate actions to protect its interests later, and does not mean Myriad Studio waives its rights in the event of subsequent identical or similar violations.

18. FINAL PROVISIONS

The Parties to the present Agreement recognize electronic correspondence between themselves as written evidence.

The present User Agreement is subject to the law of the territorial jurisdiction at the location of Myriad Studio. For Services provided by Affiliates, their respective jurisdictions apply.

Any User of the Service hereby confirms that they have read, understood, accepted, and fully agree with the content of this User Agreement and undertake to comply with it.
